3. BUSINESS

- A. Acceptance and appropriation of \$1,500 from the Friends of the Public Library to the Library Gift Account to be used for digital content and adult book clubs.
- B. Acceptance and appropriation of a \$3,000 donation from the Friends of the Cheshire Public Library to the Friends Library of Things Gift Account for general purposes.
- C. Acceptance and appropriation of a \$1,000 donation from Common Goal Associates to the Police Department Gift Account for general purposes.
- D. Acceptance and appropriation of a \$50.00 donation from Severino Fasulo to the Jitney Bus Fund Account.
- E. Approval of tax refunds in the amount of \$2,483.89.
